Quantum Reflex Analysis (QRA)**

I acknowledge that Dr. Heise and staff members of Heise Health Clinic provide services to help me attain and maintain my best health. Dr. Heise will help determine which specific nutrients my body needs. All recommendations are designed to help me move towards my best state of health through personalized recommendations in diet, lifestyle, exercise, health habits, chiropractic adjustments and nutritional supplementation.

Office Fees

The initial QRA office visit is \$350.00 unless otherwise stated. This is based on approximately one (1) hour, but may vary according to need. If more than one hour is required for your initial QRA, you **will not** be responsible for an additional fee. Nutritional testing will be performed to pinpoint-target special body needs. In addition, QRA Kinesiological testing may be used to help identify specific needs and interference fields. Follow-up QRA appointments are usually recommended 4 – 8 weeks and occasionally at 2 weeks with more chronic/severe problems that may include interference fields on the surface of the body, scars and old trauma sites. ****These follow-up fees are \$85.00 for the QRA follow-up and \$45 for the 2 week quick check.**

Please note: If paying by check, and additional \$30.00 processing fee will be assessed for each returned check or “stop payment” check.

Deposit/Cancellation Policy

A credit card number will be requested at the time of your initial scheduled appointment. Your credit card number, on file with this office, will serve as all of your appointment deposits. In the event of a cancellation, the credit card will not be charged, **if** notification of cancellation has been received **two (2) full business days** prior to your appointment. **Please note:** Our office is closed on Tuesdays and Thursdays and we do not consider those days business days. Leaving a cancellation voicemail message will not be acceptable. If your appointment is not cancelled or rescheduled within the 2 full business days prior to your appointment, then the credit card on file will be charged for the full appointment fee.

Follow-up Questions and Telephone Consultations

If you have questions about your treatment, following your initial or follow-up visits, we do not charge for brief telephone consultations provided you have purchased the recommended nutrients through this office. If you decide not to purchase the recommended nutrients prescribed by Dr. Heise through this office you will be assessed \$65.00 for any part of the first 15 minutes and \$20 for every five (5) additional minutes.

**** (Fees are based upon patient purchasing prescribed nutrients from this office. If you decide not to purchase the recommended nutrients prescribed by Dr. Heise through this office then the follow-up fees are as follows: \$170 for the QRA follow-up and \$85 for the 2 week quick check.)**
